YEAR UNDER REVIEW

The branch had recommenced the physical meetings for members during the year after the Pandemic.

a. CPE Programs

The Branch had organised **90** CPE Hours for Members (in Physical and Virtual modes) during the year on wide range of topics.

b. Class room training for Students

The branch had organised **12** batches of Orientation Programs, **06** batches of MCS programs, **16** batches of Information Technology and **06** batches of Advanced ITT programs during the year. Around 1600 students had benefitted from these programs.

c. Member Strength

The total member strength of the branch stands at **2702 (Two thousand seven hundred and two)** thereby making the branch as the largest branch in the State of Tamilnadu.

d. Allotment of Land

The branch had obtained the lease of land from Rail Land Development Authority (RLDA) during the year. The possession of the land and the registration of Lease Document had also been completed during the year.

FUTURE PLANS


The Management Committee of the branch endeavours to continue their services and to provide all the facilities to the members and students in the coming years.
